MEMORANDUM OF UNDERSTANDING
BETWEEN
JAPAN NETWORK INFORMATION CENTER
AND
VIET NAM INTERNET NETWORK INFORMATION CENTER

This Memorandum of Understanding (“MoU”) is made as of 27th September 2022, by and between Japan Network Information Center (JPNIC) and Viet Nam Internet Network Information Center (VNNIC) in Ha Noi, Viet Nam. In this MoU, JPNIC and VNNIC are referred to individually as “Party”.

WITNESSETH:

WHEREAS, the parties recognize the need for mutual understanding and cooperation in the field of Internet resources management.

WHEREAS, the parties desire to establish the framework for cooperative activities which are deemed to be mutually beneficial and acceptable for both parties;

NOW THEREFORE, in consideration of the foregoing premises and mutual covenants hereinafter provided, the Parties hereby agree as follows:

Article 1: The scope of this MoU

The parties agree to jointly identify specific activities and topics for a possible cooperation in the following areas:

- Strategy and policy:

The parties agree to exchange information about general strategies, policies technologies and technical issues in the field of Internet, Internet resources management, critical Internet infrastructure and Internet governance which would be then executed by the parties; exchange information and experiences in the promotion of Internet, Internet resources and Internet governance in the community.

- IP Address/AS Number management & NIR activities

The parties agree to exchange the information and experiences in IP Address/ AS Number management and National Internet Registry System evolution in each country and in the region; cooperate to develop the management policy of IP Address/ AS Number in the region and to foster engagement and cooperation amongst NIRs.

- IPv6 Promotion

The parties agree to cooperate to foster IPv6 deployment, including the activities of exchange information about IPv6 deployment strategy, general policies, statistics and measurements, promotion activities in each country; to exchange experiences in deployment of next generation of Internet with IPv6 (5G with IPv6, AI with IPv6, IoT with IPv6,...).

- Routing Security

The parties agree to cooperate and exchange knowledge and activities in the area of routing security such as Resource Public Key Infrastructure (RPKI).

- Internet safety and security

The parties agree to exchange information, data associated with Internet resources in each country to provide additional context in investigations and threat detections towards Internet safety and security.

- IT human resources development

The parties agree to cooperate to expand the cooperation in developing IT human resources by sharing materials, knowledge and insights, collaborating in technical training courses and seminars with a focus on Internet number, Internet security, emerging technologies and Internet governance; to cooperate or support activities and projects initiated by the party(ies) towards Internet human resources development.

Article 2: Implementation

Upon signing this MoU, the Parties agree to do their reasonable endeavor to carry out further cooperation plans and activities. Based on the execution of the specific activities under the scope of this MoU, the parties will consider signing other specific agreements.

During the term of this MoU, the parties can also consider to amend the contents in this MoU upon further discussion and when there should be any issues arising from the implementation of this MoU.

Article 3: Duration

This MoU shall enter into force on the date of signature. During the term of the MoU, either party can give the other party at least three (03) months prior written notice of its intention to terminate or continue this collaboration.
